

RESOLUTION NO. 78

A RESOLUTION DETERMINING THAT NO ELECTION WILL BE HELD  
AND REQUESTING THE BOARD OF SUPERVISORS, SAN BENITO  
COUNTY, TO APPOINT TWO (2) DIRECTORS

SUNNYSLOPE COUNTY WATER DISTRICT

RESOLVED, by the Board of Directors of the Sunnyslope  
County Water District County of San Benito, State of California,  
that

WHEREAS, the Board of Directors of this District adopted and  
passed a resolution providing for the 1967 General District Election,  
pursuant to the Uniform District Election Law of the State of Cali-  
fornia, for the election of Two (2) Directors to said District;

WHEREAS, the Notice of Election was published once, namely on  
August 23, 1967, in the Evening Free Lance a news-  
paper of general circulation published in the County of San Benito  
there being no such newspaper published in this District.

WHEREAS, a similar Notice of Election was also posted at the  
District office as required by law;

WHEREAS, nomination petition forms were made available by this  
District's Secretary on Thursday, August 24, 1967, and until Monday,  
September 18, 1967;

WHEREAS, a Notice of Insufficient Nominees was published once  
in the Evening Free Lance;

WHEREAS, as of Monday, September 18, 1967, at the closing hour  
of five (5) o'clock p.m. only two (2) nomination petitions were  
filed with the Secretary of this District; and

WHEREAS, until Friday, September 22, 1967, five (5) o'clock  
p.m., no petition signed by five percent (5%) of the electors in  
this District, requesting that the general district election be held  
for such offices was presented to or received by the Secretary of  
this District.

NOW, THEREFORE, IT IS DETERMINED and ORDERED, as follows:

1. That the number of nomination petitions timely filed with the Secretary of this District do not exceed the number of offices to be filled.

2. That no election to fill the vacancies on the **Board of Directors** of this District will be held on November 7, 1967.

3. That the Secretary is directed to file with the County Clerk a certified copy of this resolution, requesting the Board of Supervisors of **San Benito** County to appoint to the office of **Director** as soon as convenient but prior to the date fixed for the general district election, the following persons nominated:
