

ORDINANCE NO. 41

AN ORDINANCE OF THE SUNNYSLOPE COUNTY WATER DISTRICT AMENDING ORDINANCE NO. 4 ENTITLED "AN ORDINANCE ESTABLISHING RATES, RULES AND REGULATIONS FOR WATER SERVICE BY THE SUNNYSLOPE COUNTY WATER DISTRICT" AND ADDING SECTION 129 THERETO PROVIDING INSPECTION FEES FOR WATER SYSTEMS WITHIN DISTRICT BOUNDARIES, PROVIDING FOR MODIFICATION THEREOF BY RESOLUTION AND REPEALING OTHER ORDINANCES OR PARTS THEREOF IN CONFLICT WITH THIS ORDINANCE

BE IT ORDAINED by the Board of Directors of the Sunnyslope County Water District, San Benito County, California, as follows:

Section 1. Article 7 of Ordinance Number 4 entitled "An Ordinance Establishing Rates, Rules and Regulations for Water Service by the Sunnyslope County Water District", passed and adopted September 8, 1955, is hereby amended by adding Section 129 thereto, to read as follows:

"Section 129. Administrative, Engineering and Inspection Fees. The District shall charge inspection fees to cover the District's administrative and engineering costs for inspecting water facilities for new construction or development located within the District's boundaries. The inspection fees shall be based upon the estimated cost of construction of the water lines and appurtenances and shall be established at least annually by resolution of the Board of Directors.

The fees established pursuant to this section shall be paid in advance of the District's inspection. In the event fees are not so paid in advance, the District shall have no obligation to perform any such inspection until such fees are paid.

Fees established pursuant to the authority granted in this section shall be reviewed at least annually. Any modification of the fee schedule shall be accomplished by resolution of the District Board of Directors.

Legal fees, if any, incurred by District for performing its administrative and engineering services and inspections shall be paid in advance by the subdiviver."

Section 2. All ordinances or parts of ordinances inconsistent herewith are hereby repealed.

Section 3. If any section or phrase of this ordinance is for any reason held to be unconstitutional, such decision shall not affect the validity of the remaining portions of this ordinance.

Section 4. This ordinance shall be in full force and effect at 12:01 a.m. on the 30th day after its passage and shall be published once in the Evening Free Lance, a newspaper of general circulation published and printed in the County of San Benito, State of California, together with the names of the members of the Board of Directors voting for and against same prior to fifteen (15) days from passage hereof.

RESOLUTION OF THE SUNNYSLOPE COUNTY WATER  
DISTRICT ESTABLISHING INSPECTION FEES PURSUANT  
TO ORDINANCE NO. 41

WHEREAS, Ordinance No. 41 provides that the Sunnyslope County Water District shall initially establish inspection fees and at least annually thereafter, review the fee structure and

WHEREAS, the Board of Directors has reviewed a proposed fee structure and is prepared to established initial inspection fees,

NOW, THEREFORE, the Board of Directors of the Sunnyslope County Water District resolve as follows:

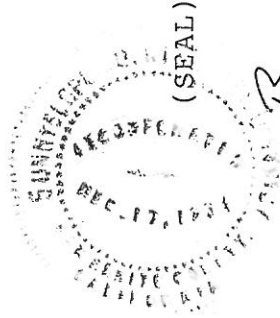
1. Inspection fee schedule: The following fees shall be charged for District inspection of water facilities, subdivisions or new developments, which fees are based upon the estimated cost of construction of the water lines and appurtenances:

<u>Estimated Cost of Construction</u>	<u>Inspection Fee</u>
First \$ 50,000	5 %
\$50,001 to \$150,000	4 %
Over \$150,001	3 %

2. Review of fee schedule: The fee schedule established in this Resolution shall be reviewed at least annually. Unless earlier reviewed, this schedule shall be placed on the Board of Directors' April agenda for each year to determine if the established fee structure adequately meets the needs of the District.
