AN ORDINANCE AMENDING SECTION 9.6 OF ORDINANCE NO. 15 ENTITLED "AN ORDINANCE REGULATING THE USE OF PUBLIC AND PRIVATE SEWERS, THE INSTALLATION OF SEWER LATERALS AND PUBLIC SEWER MAIN EXTENSIONS, PROVIDING FOR THE EMPLOYMENT OF A SANITARY INSPECTOR, PROVIDING PERMITS AND FIXING FEES FOR THE INSTALLATION OF SANITARY SEWER LATERALS AND REGULATING THE DISCHARGE OF WATERS AND WASTES INTO THE PUBLIC SEWER SYSTEM OF THE SUNNYSLOPE COUNTY WATER DISTRICT"

BE IT ORDAINED, by the Board of Directors of the Sunnyslope County Water District, San Benito County, California, as follows:

Section 1. Article IX. Section 9.6. of Ordinance No. 15 as amended, is hereby amended to read as follows:

"Section 9.6 Fees - Annexation Charges. The owner or owners of lands within areas proposed to be annexed to the District shall deposit with the Secretary of the District, prior to commencement of proceedings by the Board of Directors of District on the proposed annexation, a sum to be fixed by the Board of Directors of District. The sum to be fixed shall be the estimated cost of engineering, legal and publication costs and all other charges which may be incurred by the District in preparing and examining maps, legal descriptions, and other documents in relation thereto, and other expenses regularly incurred in connection therewith. Should the amount of the deposit exceed the costs incurred by the District the excess shall be refunded to the owner or owners making the deposit following the conclusion of the final hearing on the proposed annexation. Should the amount of the deposit be insufficient to pay such costs incurred by the District, said owner or owners shall advance such additional sums as may be necessary to pay said costs prior to the conclusion of the final hearing on the proposed annexation."

Section 2. All ordinances and parts of ordinances inconsistent herewith are hereby repealed.

Section 3. This ordinance shall be in full force and effect at 12:01 a.m. on the 30th day after its passage and shall be published once in the Evening Free Lance, a newspaper of general circulation published and printed in the county of San Benito, State of California, together with the names of the members of the Board of Directors voting for and against same prior to 15 days from passage hereof.
